- The protection of helmet choice for adult motorcyclists.
- Removal of the handlebar height law for motorcycles.
- Stopped unreasonable insurance requirements for motorcyclists.
- Made motorcyclist awareness license plates available.
- · Removed restrictions for riders on a learner's permit which increased the safety of new
- Provided an "affirmative defense" for motorcyclists who proceed through a red light that has not recognized the motorcycle.
- Legalized trained motorcyclists who take a training course to become Road Guards on organized motorcycle runs.
- Worked with a coalition of groups to increase the penalties for distracted driving.
- Adjusted endorsement renewal fees to improve funding for motorcycle safety.
